

SUPPLEMENTARY DEED OF AGREEMENT

ST JOSEPH'S SCHOOL, OPUNAKE

THIS DEED OF AGREEMENT is made on the 19th day of FEBRUARY
One thousand nine hundred and eighty ~~five~~ ^{six} (1986)


BETWEEN THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF
PALMERSTON NORTH a "Corporation Sole" (hereinafter
with his successors referred to as "the Proprietor")
of the first part and HER MAJESTY THE QUEEN acting
by and through the Minister of Education (hereinafter
referred to as "the Minister") of the second part

WHEREAS

- A By Deed of Agreement bearing date the 14th
day of September 1982 as varied by any subsequent
supplementary agreements (hereinafter referred
to as "the Deed of Agreement"), the Minister
and the Proprietor pursuant to section 7(2) of
the Private Schools Conditional Integration
Act 1975 established **ST JOSEPH'S SCHOOL,
OPUNAKE** as an integrated school.
- B The Proprietor and the Minister are now agreed
on the need to amend Clause 8 of the Deed of
Agreement pursuant to Section 7(9) of the
Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY
COVENANTED AGREED AND DECLARED BY AND BETWEEN THE
PARTIES HERETO AS FOLLOWS:

- 1 THAT the words "one hundred and fifty-four (154)"
in the 4th line in Clause 8 of the Deed of
Agreement be deleted from that Agreement and
the words "one hundred and seventy (170)" be
substituted therefor.
- 2 THAT the Third Schedule to the Deed of Agreement
be amended by adding under the heading
"BUILDING REQUIREMENTS" the following "Additional
teaching space of 65m² and provision of further
28m² to convert the bookroom to a library.
These items are to be completed by 31 March
1989."



3 **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
