SUPPLEMENTARY DEED OF AGREEMENT

ST JOSEPH'S SCHOOL, ORAKEI, AUCKLAND

THIS DEED OF AGREEMENT is made on the 29 day of two thousand and fourteen (2014) BETWEEN THE ROMAN CATHOLIC

BISHOP OF THE DIOCESE AUCKLAND a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and HER MAJESTY

THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS

- A By Deed of Agreement bearing date the 28th day of September 1982 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **St**Joseph's School, Orakei as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1. <u>THAT</u> the words "one hundred and twenty five (125) pupils" in the 4th line in clause 8 of the Deed of Agreement be deleted from that Agreement and the words "one hundred and fifty (150) students from Term 1 2015 and one hundred and seventy five (175) students from Term 3 2015" be substituted therefor.
- 2. <u>THAT</u> in clause 10 (b) of the Deed of Agreement the words "ten (10) pupils out of the total roll" be deleted from that Agreement and the words "five (5%) percent of the maximum roll" be substituted therefor.
- 3. <u>THAT</u> the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
