

SUPPLEMENTARY DEED OF AGREEMENT

ST JOSEPH'S SCHOOL, OTAHUHU

THIS DEED OF AGREEMENT is made on the *5th* day of *February*

One thousand nine hundred and eighty five (1985)

BETWEEN

THE ROMAN CATHOLIC BISHOP OF THE DIOCESE

OF AUCKLAND

a "Corporation Sole" (hereinafter with his

successors referred to as "the proprietor") of the first part

AND

HER MAJESTY THE QUEEN acting by and through the Minister of

Education (hereinafter referred to as "the Minister") of the

second part

WHEREAS

A. The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 31st day of March 1983

for St Joseph's School Otahuhu

(hereinafter referred to as the "original Deed of Agreement")

B. The Proprietor and the Minister pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975 signed a supplementary Deed of Agreement on the 13th day of September 1983

C. The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED

AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS

FOLLOWS:-

1 THAT the words " two hundred and eighty (280) pupils"

in the 4th line in Clause 8 of the original Deed of Agreement be deleted

from that Agreement and the words "three hundred and five (305) pupils"

be substituted therefor.



2 THAT the covenants conditions and restrictions contained and implied in the original deed of agreement shall be read and construed subject to the modifications herein contained but in all other respects the original deed of agreement is confirmed.
