## NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1. THAT the words "one hundred and twenty (120)" in the 5th line in Clause 8 of the Deed of Agreement be deleted from the Agreement and the words "one hundred and fifty (150)" be substituted therefor.
- 2. THAT the Third Schedule of the original Deed of Agreement be amended by adding the words

"one (1) x 63m² teaching space and toilets;

toilets: 2 pan female, 1 pan and equal urinal male;

Library space 20m² additional".

This accommodation is be provided when required by the actual roll.

3. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
