

SUPPLEMENTARY DEED OF AGREEMENT

ST JOSEPH'S CATHOLIC SCHOOL, PAEROA

THIS DEED OF AGREEMENT is made on the

7th day of November

One thousand nine hundred and ninety-six (1996) BETWEEN THE ROMAN

CATHOLIC BISHOP OF THE DIOCESE OF HAMILTON a Corporation Sole

(hereinafter with its successors referred to as "the Proprietor") of the first part

and HER MAJESTY THE QUEEN acting by and through the Minister of

Education (hereinafter referred to as "the Minister") of the second part

WHEREAS

A By Deed of Agreement bearing date the Sixteenth (16) day of February, One thousand and Nine Hundred and eighty-two (1982) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **ST JOSEPH'S CATHOLIC SCHOOL, PAEROA** as an integrated school (hereinafter referred to as "the School").

B The Proprietor and the Minister are now agreed on the need to amend the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

**NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY
COVENANTED AGREED AND DECLARED BY AND BETWEEN THE
PARTIES HERETO AS FOLLOWS:**

1. THAT the words "one hundred and twenty (120)" in the 5th line in Clause 8 of the Deed of Agreement be deleted from the Agreement and the words "one hundred and fifty (150)" be substituted therefor.

2. THAT the Third Schedule of the original Deed of Agreement be amended by adding the words

"one (1) x 63m² teaching space and toilets;

toilets: 2 pan female, 1 pan and equal urinal male;

Library space 20m² additional".

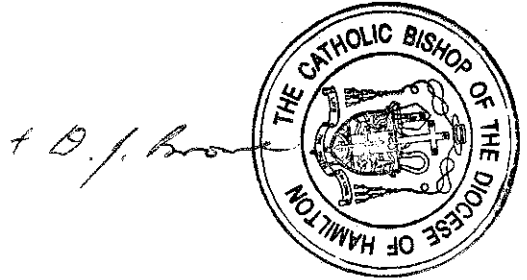
This accommodation is to be provided when required by the actual roll.

3. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
