

SUPPLEMENTARY DEED OF AGREEMENT

ST JOSEPH'S SCHOOL, PAPANUI, CHRISTCHURCH

THIS DEED OF AGREEMENT is made on the 20 day of January two thousand and eleven (2011) between the **ROMAN CATHOLIC BISHOP OF THE DIOCESE OF CHRISTCHURCH** a Corporation Sole (hereinafter with its successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS

- A By Deed of Agreement bearing date the 10th day of July 1980 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **St Joseph's School, Papanui, Christchurch** as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

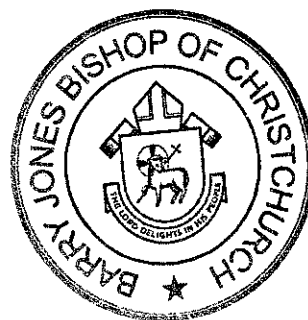
1. **THAT** the Plan annexed to the Second Schedule of the Deed of Agreement be deleted and the Plan annexed hereto be substituted therefor.
2. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.

I, PATRICK JOHN BEBAN of Christchurch, in New Zealand, Diocesan Financial Administrator hereby certify:-

1. That by Deed dated 22nd August 2007 **BARRY PHILIP JONES** of Christchurch in New Zealand, Roman Catholic Bishop of the Diocese of Christchurch, in exercise of the powers contained in Section 23 of the Roman Catholic Bishops Empowering Act 1997 appointed me his Delegate on the terms and subject to the conditions set out in the said Deed.
