

SUPPLEMENTARY DEED OF AGREEMENT

THIS DEED OF AGREEMENT is made on the 4th day of November
One Thousand nine hundred and eighty eight BETWEEN THE
ROMAN CATHOLIC BISHOP OF THE DIOCESE OF AUCKLAND a
'Corporation Sole' (hereinafter with his successors
referred to as "the Proprietor") of the first part and HER
MAJESTY THE QUEEN acting by and through the Minister of
Education (hereinafter referred to as "The Minister") of
the second part

WHEREAS

- A By Deed of Agreement bearing date the 27th January
1983 as varied by any subsequent supplementary
agreements (hereinafter referred to as "the Deed of
Agreement"), the Minister and the Proprietor pursuant
to section 7(2) of the Private Schools Conditional
Integration Act 1975 established St. Joseph's School,
Pukekohe as an integrated school.
- B The Proprietor and the Minister are now agreed on the
need to amend Clause 8 of the Deed of Agreement
pursuant to section 7(9) of the Private Schools
Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY
COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES
HERETO AS FOLLOWS:

1. THAT the words "two hundred and forty (240)" in the 4th line in clause 8 of the Deed of Agreement be deleted from that Agreement and the words "two hundred and eighty five (285) " be substituted therefor.

2. THAT the Third Schedule of the original Deed of Agreement be amended by adding under the heading "Building Requirements" the words "additional: teaching space 65m²; resource workroom increased by 14m², staffroom increased by 5m², storage increased by 6m² ". This accommodation is to be provided by 1992. This work specified above is in addition to the work listed in the third schedule.

3. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
