## BETWEEN THE ROMAN CATHOLIC BISHOP OF THE DIOCESE

OF DUNEDIN a "Corporation Sole" (hereinafter with his successors referred to as "the proprietor") of the first part HER MAJESTY THE QUEEN acting by and through the Minister of

Education (hereinafter referred to as "the Minister") of the second part

## **WHEREAS**

AND

- A. The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 17th day of June 1980 for Saint Joseph's Primary School, Queenstown (hereinafter referred to as the "original Deed of Agreement")
- B. The Proprietor and the Minister pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975 signed a supplementary Deed of Agreement on the 24th day of May 1983 (hereinafter referred to as the "first supplementary Deed of Agreement").
- C. The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY CONVENANTED

AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS

FOLLOWS:-

THAT the words " fifty eight (58)"

in the 5th line in Clause 8 of the original Deed of Agreement be deleted from that Agreement and the words "ninety (90)" be substituted therefor.
