

SUPPLEMENTARY DEED OF AGREEMENT

ST JOSEPH'S SCHOOL, STRATFORD

THIS DEED OF AGREEMENT is made on the 19 day of OCTOBER

One thousand nine hundred and eighty-two (1982) BETWEEN

THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF PALMERSTON NORTH

a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part AND HER MAJESTY THE QUEEN

acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

WHEREAS

A The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 27th day of October 1981 for St Joseph's School, STRATFORD (hereinafter referred to as the "original Deed of Agreement").

B The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:-

1. THAT the words "one hundred and eighty-five (185) pupils" in the 5th line in Clause 8 of the original Deed of Agreement be deleted from that Agreement and the words "two hundred and five (205) pupils" be substituted therefor.

2. THAT the Third Schedule to the original Deed of Agreement be amended on page 29 of that agreement under the words "Provide the following accommodation by remodelling"

(a) by deleting the words "staffroom 14m<sup>2</sup>" and inserting the following words in substitution thereof: "staffroom 18.5m<sup>2</sup>"




(b) by adding as a new item the words "increase teaching space to 455m<sup>2</sup>".

These items are to be completed by 31 March 1985.
