SUPPLEMENTARY DEED OF AGREEMENT

ST JOSEPH'S SCHOOL, TE KUITI

THIS DEED OF AGREEMENT is made on the 3rd day of two thousand and four (2004) BETWEEN THE ROMAN CATHOLIC BISHOP OF HAMILTON a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS

- A By Deed of Agreement bearing date the 26th day of September one thousand nine hundred and eighty one (1981) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **St Joseph's School, Te Kuiti** as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to change clause 8 pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1. <u>THAT</u> the words "one hundred and twelve (112) pupils" in the 5th line in clause 8 of the Deed of Agreement be deleted from that Agreement and the words "one hundred and twenty (120) pupils" be substituted therefore.
- 2. THAT in clause 10(b) of the Deed of Agreement the words "five (5) percent of the maximum roll" be deleted from that Agreement and the words "six (6) pupils" be substituted therefore.
- 3. <u>THAT</u> the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
