

SUPPLEMENTARY DEED OF AGREEMENT
SAINT JOSEPH'S PRIMARY SCHOOL, UPPER HUTT.

THIS DEED OF AGREEMENT is made on the 11 day of *September*
One thousand nine hundred and eighty-one (1981) BETWEEN THE
ROMAN CATHOLIC ARCHBISHOP OF THE ARCHDIOCESE OF WELLINGTON a
"Corporation Sole" (hereinafter with his successors referred
to as "the Proprietor") of the first part AND HER MAJESTY THE
QUEEN acting by and through the Minister of Education (hereinafter
referred to as "the Minister") of the second part

WHEREAS

- A The Proprietor and the Minister pursuant to Section 7 (2) of
the Private Schools Conditional Integration Act 1975 signed
an integration agreement on the 30th day of June 1980 for St.
Joseph's Primary School, Upper Hutt.
- B The Proprietor and the Minister are now agreed on the need to
delete Clause eight (8) of that original Deed of Agreement and
to substitute a new Clause in its place pursuant to Section 7 (9)
of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED
AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:-


1. THAT Clause 8 in the said integration agreement for Saint
Joseph's Primary School, Upper Hutt signed on the 30th day of June
1980 be deleted from that agreement.

2. THAT the following clause be inserted therefor:

"8. THE School had a roll of five hundred and fifty-one (551)
pupils as at the 30th September 1979 being the year when the
roll figures were last compiled. It is agreed by and between
the parties hereto that the maximum roll of the School shall
be five hundred and eighty (580) pupils."

3. THAT the covenants conditions and restrictions contained and
implied in the said Deed of Agreement shall be read and construed
subject to the modifications herein contained but in all other
respects the said Deed of Agreement is confirmed.


