THIS DEED OF AGREEMENT is made on the day of This one thousand nine hundred and ninety-three (1993) BETWEEN

NORTH a Corporation Sole (hereinafter with his successors referred to as "the Proprietor") of the first part and HER

MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS

- By Deed of Agreement bearing date the 7th day of December 1982 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established St Joseph's School, Waipukurau as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to redefine the Proprietor's Land and the School Premises as defined in the First and Second Schedules to the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY

COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES

HERETO AS FOLLOWS:

1. THAT the words "1. The Archdiocesan Development Fund of the Archdiocese of Wellington and Diocese of Palmerston North. 2. The Bank of New Zealand" in the First Schedule of the Deed of Agreement be deleted from that Agreement and the words "1. The Diocesan Development Fund of the Diocese of Palmerston North. 2. The Housing Corporation of New Zealand" be substituted therefor.
