SUPPLEMENTARY DEED OF AGREEMENT

SAINT JOSEPH'S SCHOOL, WAITARA

THIS DEED OF AGREEMENT is made on the 5th day of December

One thousand nine hundred and eighty four (1984)

BETWEEN THE ROMAN CATHOLIC BISHOP OF THE DIOCESE

OF PALMERSTON NORTH

a "Corporation Sole" (hereinafter with his

successors referred to as "the proprietor") of the first part

AND

HER MAJESTY THE QUEEN acting by and through the Minister of

Education (hereinafter referred to as "the Minister") of the

second part


WHEREAS

- A. The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 8th day of October 1980 for Saint Joseph's School, WAITARA (hereinafter referred to as the "original Deed of Agreement")
- B. The Proprietor and the Minister pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975 signed a supplementary Deed of Agreement on the 22nd day of March 1983
- C. The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY CONVENANTED
AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS
FOLLOWS:-

1 THAT the words "two hundred and ten (210) pupils"

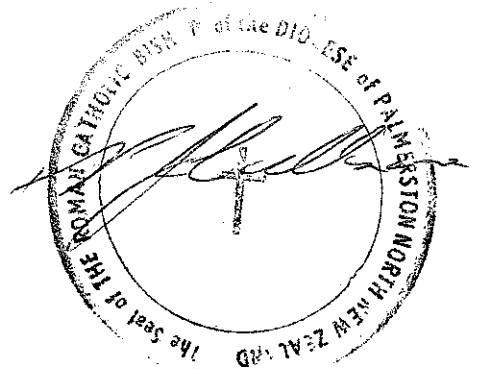
in the 5th line in Clause 8 of the original Deed of Agreement be deleted from that Agreement and the words "two hundred and twenty (220) pupils" be substituted therefor.
