

SUPPLEMENTARY DEED OF AGREEMENT

ST JOSEPH'S SCHOOL, WHAKATANE

THIS DEED OF AGREEMENT is made on the 7<sup>th</sup> day of February

One thousand nine hundred and eighty five (1985) BETWEEN

THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF HAMILTON

a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part AND HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

WHEREAS

A The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 12th day of October 1982 for St Joseph's School, Whakatane

(hereinafter referred to as the "original Deed of Agreement")

B The Proprietor and the Minister are now agreed on the need to amend Clause 8 on the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED, AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1 THAT the words "two hundred and seventy (270) pupils" in the 4th line in Clause 8 of the original Deed of Agreement be deleted from that Agreement and the words "two hundred and eighty (280) pupils" be substituted therefor.

2 THAT the Third Schedule to the original Deed of Agreement be amended on page number 23 of that Agreement by deleting under the heading "Provide by new construction or remodelling the following" the words "Resource work room of 14m<sup>2</sup> storage of 5m<sup>2</sup> " and adding the words "teaching space 65m<sup>2</sup> resource work room of 28m<sup>2</sup> staff kitchen of 4.5m<sup>2</sup> storage of 19m<sup>2</sup> staffroom of 5m<sup>2</sup>."

These items are to be completed by 31 March 1987.

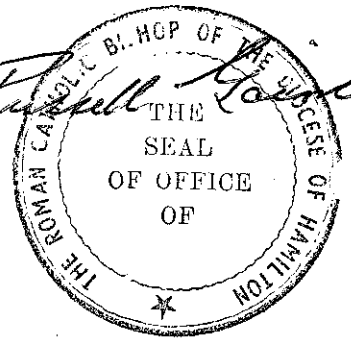
