

SUPPLEMENTARY DEED OF AGREEMENT

ST MARK'S SCHOOL, PAKURANGA

THIS DEED OF AGREEMENT is made on the 12th May
One thousand nine hundred and ninety^{three}~~two~~³ (199~~2~~³) BETWEEN
THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF AUCKLAND a
Corporation Sole (hereinafter with his successors
referred to as "the Proprietor") of the first part and
HER MAJESTY THE QUEEN acting by and through the Minister
of Education (hereinafter referred to as "The Minister"
of the second part.

WHEREAS

A By Deed of Agreement bearing date the 22 day of
November 1981 as varied by any subsequent
supplementary agreements (hereinafter referred to as
"the Deed of Agreement"), the Minister and the
Proprietor pursuant to Section 7(2) of the Private
Schools Conditional Integration Act 1975 established
St Mark's School, Pakuranga as an integrated school
(hereinafter referred to as "the School").

B The Proprietor and the Minister are now agreed on
the need to redefine the Proprietor's Land and the
School Premises as defined in the First and Second
Schedules to the Deed of Agreement pursuant to
Section 7(9) of the private Schools Conditional
Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY
COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES
HERETO AS FOLLOWS:

1. THAT the Deed of Agreement bearing date the 22 day
of November 1981 is hereby amended by deleting and
cancelling the Second Schedule and annexed Plan.

2. THAT the Schedule and Plan attached to this supplementary Deed of Agreement are hereby substituted as the Second Schedule defining the School Premises in the Deed of Agreement.

3. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.

SECOND SCHEDULE

Description of land, buildings and other improvements comprising the School premises.

The School Premises:

All that part of the Proprietor's land as described in the First Schedule hereto, delineated in red on the annexed plan of the Proprietor's land, which forms part of this Schedule, TOGETHER WITH all the School buildings and other improvements thereon SAVE AND EXCEPT Block E, F and the land immediately surrounding the same more particularly delineated on the annexed plan shown in diagonal shading (hatched) TOGETHER WITH a reservation reserving to the Proprietor full rights to use the sealed area and access way shaded on the annexed plan from and to the Pakuranga - Howick Main Highway.
