


SUPPLEMENTARY DEED OF AGREEMENT

St Mark's Catholic School, Pakuranga



THIS DEED OF AGREEMENT is made on the 15th day of August One Thousand nine hundred and ninety (1990) BETWEEN THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF AUCKLAND a Corporation Sole (hereinafter with his successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS

- A** By Deed of Agreement bearing date the 22nd day of November 1981 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established St Mark's Catholic School, Pakuranga as an integrated school.
- B** The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1. THAT** the words "three hundred and sixty-five (365)" in the 5th line in clause 8 of the Deed of Agreement be deleted from that Agreement and the words "three hundred and seventy-five (375) " be substituted therefor.

2. THAT the Third Schedule of the original Deed of Agreement be amended by adding under the heading 'Building Requirements' the words 'classroom of 66m²; junior resource room of 14m²; staffroom accommodation of 9m²; kitchen area of 4.5m²'. This accommodation is to be provided by 1990.

3. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
