

SUPPLEMENTARY DEED OF AGREEMENT

SAINT MARK'S CATHOLIC SCHOOL, PAKURANGA

THIS DEED OF AGREEMENT is made on the 29th day of January
One thousand nine hundred and eighty five (1985)

BETWEEN

THE ROMAN CATHOLIC BISHOP OF THE DIOCESE

OF AUCKLAND

a "Corporation Sole" (hereinafter with his
successors referred to as "the proprietor") of the first part

AND

HER MAJESTY THE QUEEN acting by and through the Minister of
Education (hereinafter referred to as "the Minister") of the

second part

WHEREAS

- A. The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 22nd day of November 1981 for Saint Mark's Catholic School, Pakuranga (hereinafter referred to as the "original Deed of Agreement")
- B. The Proprietor and the Minister pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975 signed a supplementary Deed of Agreement on the 20th day of May 1982 (hereinafter referred to as the "first supplementary Deed of Agreement").
- C. The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED
AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS
FOLLOWS:-

- 1 THAT the words "two hundred and eighty two (282) pupils" in the 5th line in Clause 8 of the original Deed of Agreement be deleted from that Agreement and the words "three hundred and thirty two (332) pupils" be substituted therefor.

2 THAT the Third Schedule to the original Deed of Agreement be amended on page number 22 of that Agreement by adding under the heading "Provide by new construction or remodelling the following" the words "Additional teaching space of 65m² and a junior resource/workroom of 14m²." These items are to be completed by 31 March 1987.

3 THAT the covenants conditions and restrictions contained and implied in the original deed of agreement shall be read and construed subject to the modifications herein contained but in all other respects the original deed of agreement is confirmed.
