SUPPLEMENTARY DEED OF AGREEMENT

ST MARY'S SCHOOL, BLENHEIM

THIS DEED OF AGREEMENT is made on the two thousand (2000) BETWEEN THE ROMAN CATHOLIC ARCHBISHOP OF THE ARCHDIOCESE OF WELLINGTON a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS

- By Deed of Agreement bearing date the third (3rd) day of December, one thousand, nine hundred and eighty-one (1981) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established ST MARY'S SCHOOL, BLENHEIM as an integrated school (hereinafter referred to as "the School").
- The Proprietor and the Minister are now agreed on the need to amend the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1. THAT the Plan attached to the Second Schedule of the Deed of Agreement be deleted and replaced by the Plan attached hereto.
- 2. THAT by December 2000 or such other date as may be agreed between the Proprietor and the Minister, the Proprietor will construct a school hall to Ministry of Education standards on the land marked 'Future Hall' on the Plan attached hereto.
- 3. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
