

SUPPLEMENTARY DEED OF AGREEMENT

ST. MARY'S PRIMARY SCHOOL, GREAT NORTH ROAD, AVONDALE

THIS DEED OF AGREEMENT is made on the *19th* day of *October*
One thousand nine hundred and ninety-two (1992) BETWEEN
THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF AUCKLAND a
Corporation Sole (hereinafter with his successors referred
to as "the Proprietor") of the first part and HER MAJESTY
THE QUEEN acting by and through the Minister of Education
(hereinafter referred to as "The Minister") of the second
part

WHEREAS

- A By Deed of Agreement bearing date the 30th day of August 1982 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established St. Mary's Primary School, Great North Road, Avondale as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend Recital B on page 1 and Clause 23 of the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. THAT the words "for girls from new entrants to Form Two (2) and boys from new entrants to Standard Four (4)" in Recital B on page 1 and in lines 1 and 2 of Clause 23 of the Deed of Agreement be deleted from that Agreement, and that the words "for boys and girls from new entrants to Form Two (2)" be substituted therefor.

2. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
