SUPPLEMENTARY DEED OF AGREEMENT

ST MARY'S SCHOOL, BLENHEIM

THIS DEED OF AGREEMENT is made on the 20th day of July one thousand nine hundred and ninety eight (1998) **BETWEEN THE ROMAN CATHOLIC ARCHBISHOP OF THE ARCHDIOCESE OF WELLINGTON**, a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS

- A** By Deed of Agreement bearing date the third (3rd) day of December, one thousand, nine hundred and eighty-one (1981) as varied by subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **St Mary's School, Blenheim** as an integrated school (hereinafter referred to as "the School").
- B** The Proprietor and the Minister wish to vary the Deed of Agreement to replace the Second Schedule and the Plan attached thereto with a new Second Schedule and a new Plan pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1** **THAT** the Second Schedule to the of the Deed of Agreement and the Plan attached thereto be deleted and the new Second Schedule and Plan annexed hereto be substituted therefor.
- 2** **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
