

SUPPLEMENTARY DEED OF AGREEMENT

ST. MARY'S PRIMARY SCHOOL, KAIKORAI

THIS DEED OF AGREEMENT is made on the *SIXTH* day of *MARCH* One Thousand nine hundred and eighty *NINE* (1989) BETWEEN THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF DUNEDIN a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS

- A By Deed of Agreement bearing date the 18th day of May 1980 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established St Mary's Primary School, Kaikorai as an integrated school (hereinafter referred to as "the school").
- B The Proprietor and the Minister are now agreed on the need to amend Recital B on Page 1 and Clause 22 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. THAT the words "for GIRLS from NEW ENTRANTS to FORM II and BOYS from NEW ENTRANTS to STANDARD II" in Recital B on page one and the words "for GIRLS from NEW ENTRANTS to FORM TWO and for BOYS from NEW ENTRANTS to STANDARD TWO" in lines 1 and 2 of Clause 22 of the Deed of Agreement be deleted from that Agreement and the words "for boys and girls from new entrants to Standard Four (4)" be substituted


