

THIS DEED OF AGREEMENT made the **22** day of **MARCH** One thousand nine hundred and eighty-three (1983)

BETWEEN THE ROMAN CATHOLIC ARCHBISHOP OF THE ARCHDIOCESE OF WELLINGTON a "Corporation Sole" (hereinafter with his successors referred to as "the Archbishop") of the first part

AND THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF PALMERSTON NORTH a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the second part

AND HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the third part

WHEREAS

- A. By Deed of Agreement bearing date the 18th day of May 1980 (hereinafter referred to as "the Deed of Agreement") the Minister and the Archbishop as proprietor pursuant to Section 7 (2) of The Private Schools Conditional Integration Act 1975 established **Saint Mary's Primary School, Hastings**, (hereinafter referred to as "the School") as an integrated school.
- B. The Roman Catholic Diocese of Palmerston North was established by decree on the 27th day of April 1980 which said Diocese thereafter included in its area the School which up until such date was formerly part of the Roman Catholic Archdiocese of Wellington
- C. The Archbishop and the Proprietor hereunder have requested the Minister to vary the Deed of Agreement in respect of the School whereby the Roman Catholic Bishop of the Diocese of Palmerston North is the Proprietor of the School pursuant to the Deed of Agreement in substitution for the Archbishop.

D. The Proprietor, the Archbishop and the Minister are now agreed on the need for entering into a Supplementary Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975 to give effect to their agreement

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO as follows:

1. THAT the Deed of Agreement bearing date the 18th day of May 1980 is hereby amended by substituting therein the name of THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF PALMERSTON NORTH a "Corporation Sole" as the Proprietor in the place of The Roman Catholic Archbishop of the Archdiocese of Wellington herein referred to as "the Archbishop" and the Archbishop is accordingly hereby discharged by the Minister and the Proprietor from all liability both present and future under or in respect of the said Deed of Agreement.

2. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.

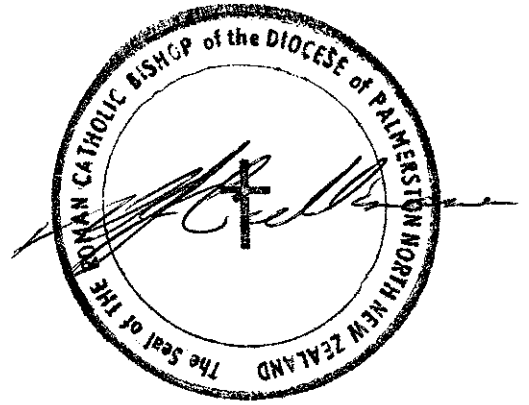
