

SUPPLEMENTARY DEED OF AGREEMENT

SAINT MARY'S PRIMARY SCHOOL, HOKITIKA

THIS DEED OF AGREEMENT is made on the 11<sup>th</sup> day of February  
One thousand nine hundred and eighty five (1985) BETWEEN  
THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF CHRISTCHURCH

a "Corporation Sole" (hereinafter with his successors referred to as  
"the Proprietor") of the first part AND HER MAJESTY THE QUEEN acting by  
and through the Minister of Education (hereinafter referred to as  
"the Minister") of the second part

WHEREAS

- A The Proprietor and the Minister pursuant to Section 7 (2) of the  
Private Schools Conditional Integration Act 1975 signed an  
integration agreement on the 29th day of August 1980  
for St Mary's Primary School, Hokitika  
(hereinafter referred to as the "original Deed of Agreement")
- B The Proprietor and the Minister are now agreed on the need to  
amend Clause 8 of the original Deed of Agreement pursuant to  
Section 7 (9) of the Private Schools Conditional Integration Act  
1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED  
AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1 THAT the words "one hundred and fifty five (155) pupils"  
in the 5th line in Clause 8 of the original Deed of Agreement be  
deleted from that Agreement and the words "one hundred and  
seventy (170) pupils" be substituted therefor.

2 THAT the Third Schedule to the original Deed of Agreement be amended on page number 3 of that Agreement by adding under the heading "Building Requirements" the following "Teaching space of 65m<sup>2</sup> , a resource/workroom of 14m<sup>2</sup> , and a library/multipurpose room of 56m<sup>2</sup>." These items are to be completed by 31 March 1986.


