NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY
COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES
HERETO AS FOLLOWS:

1. THAT the words "one hundred and ninety (190) pupils" in the 5th line of Clause 8 of the Deed of Agreement be deleted from that Agreement and the words "one hundred and ninetyfive (195) pupils" be substituted therefor.
