

SUPPLEMENTARY DEED OF AGREEMENT

ST MARY'S DIOCESAN SCHOOL STRATFORD

THIS DEED made the *24th* day of *August* 1990
BETWEEN ST MARY'S DIOCESAN SCHOOL (INCORPORATED) a society
duly incorporated under the Incorporated Societies Act 1908,
the proprietor of St Mary's Diocesan School for Girls,
Stratford (hereinafter together with its successors and assigns
called "the Proprietor") of the first part
AND HER MAJESTY THE QUEEN acting by and through the Minister of
Education (hereinafter called "the Minister") of the second
part

WHEREAS:-

- A The Proprietor and the Minister pursuant to Section 7(2) of the Private Schools Conditional Integration Act 1975 signed an Integration Agreement on the 9th day of May 1978 for St Mary's Diocesan School for Girls Stratford (hereinafter referred to as "the original Deed of Agreement").
- B The Proprietor and the Minister are now agreed on the need to amend Clause 6 of the original Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975, such clause having previously been amended pursuant to other supplementary Deeds of Agreement.

NOW THIS DEED WITNESSES AND IT IS HEREBY AGREED AND DECLARED BY
AND BETWEEN THE PARTIES AS FOLLOWS:-

1. THAT Clause 6 of the original Deed of Agreement (as amended by subsequent supplementary deeds of agreement) be deleted and the following clause be substituted therefor:-

"6. IT is agreed by and between the parties hereto that the maximum roll of the school shall be 200 pupils of whom there shall be no more than 50 day pupils (day pupils are those pupils who do not reside

in the Proprietor's boarding establishment.")

2. THAT the covenants conditions and restrictions contained and implied in the said original Deed of Agreement are confirmed.
