SUPPLEMENTARY DEED OF AGREEMENT

ST MARY'S SCHOOL, WANGANUI

THIS DEED OF AGREEMENT is made on the 15th day of November two thousand (2000) between THE ROMAN CATHOLIC BISHOP OF PALMERSTON NORTH (hereinafter with his successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS

- A By Deed of Agreement bearing date the 1st of March, one thousand, nine hundred and eighty three (1983) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **St Mary's School, Wanganui** as an integrated school (hereinafter referred to as "the school").
- B The Proprietor and the Minister are now agreed on the need to amend the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1 THAT the words "new entrants to Standard Four (4)" in Recital B and in Clause 23 be deleted and be replaced by the words "Year 0 to Year 8".
- **2** THAT following new clause be added:
 - **"23A** No Year 7 students shall be enrolled before the 2001 school year and no Year 8 students shall be enrolled before the 2002 school year."
- 3 THAT the words "one hundred and eighty (180) pupils" in the 6th line in clause 8 of the Deed of Agreement be deleted from that Agreement and the words "two hundred and forty (240) pupils" be substituted therefor.
- 4 THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
