

**SUPPLEMENTARY DEED OF AGREEMENT**

**ST MATTHEW'S COLLEGIATE SCHOOL, MASTERTON**

THIS DEED OF AGREEMENT is made on the 8<sup>th</sup> day of July two thousand and fourteen (2014) between the **Trinity Schools Trust Board** a Corporation Sole (hereinafter with his successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

**WHEREAS**

- A** By Deed of Agreement bearing date the 4<sup>th</sup> day of May, one thousand nine hundred and ninety two (1992) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **St Matthew's Collegiate School, Masterton** as an integrated school (hereinafter referred to as "the school").
- B** The Proprietor and the Minister wish to vary the deed of Agreement to amend Clause 20 of the Deed Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.


**NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:**

- 1. THAT** the words "three hundred and thirty five (335)" in the 2<sup>nd</sup> line of clause 20 of the Deed of Agreement be deleted from that Agreement and the words "three hundred and fifty five (355) allowing for 255 day students in 2014; three hundred and fifty (350) allowing for 240 day students in 2015; three hundred and fifty (350) allowing for 220 day students in 2016; three hundred and thirty (330) allowing for 200 day students in 2017; three hundred and ten (310) allowing for 180 day students from 2018 onwards" be substituted therefor.
- 2. THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.


