THIS DEED OF AGREEMENT is made on the 23rd day of April

of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

#### WHEREAS

A By Deed of Agreement bearing date the        day of        as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7 (2) of the Private Schools Conditional Integration Act 1975 established **St. Oran's College, Lower Hutt**, as an integrated school (hereinafter referred to as "the school").

B The Proprietors have acquired additional land.

C The Proprietors and the Minister are now agreed on the need to amend Clause 2 of the Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.


