

## SUPPLEMENTARY DEED OF AGREEMENT

### ST ORAN'S COLLEGE

THIS DEED OF AGREEMENT is made on the .....*28th*..... day of *February*.....

One thousand nine hundred and ninety-six (1996) between

The HUTT VALLEY PRESBYTERIAN COLLEGE FOR GIRLS INC. ("the Proprietor")

of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

#### WHEREAS

- A By Deed of Agreement bearing date the *28th* day of *February* *1996* as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7 (2) of the Private Schools Conditional Integration Act 1975 established **St. Oran's College, Lower Hutt**, as an integrated school (hereinafter referred to as "the school").
- B The Proprietors and the Minister are now agreed on the need to amend Clause 8 of the Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.
- C The Proprietors and the Minister are also now agreed on the need to amend Clause 22 and Clause 28 of the Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

**NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY  
COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES  
HERETO AS FOLLOWS:**

- 1.**           **THAT** the words "maximum roll of the School shall be two hundred and sixty four (264) pupils" in Clause 8 be deleted, and the words "maximum roll of the School shall be two hundred and eighty eight (288) pupils in the year of 1996, three hundred and twelve (312) pupils in the year of 1997 and three hundred and thirty six (336) pupils in the year of 1998" be substituted therefor.
- 2.**           **THAT** the words "established by the Ministry of Education" in Clause 22 be deleted, and the words "established pursuant to the Education Act 1989" be substituted therefor.
- 3.**           **THAT** the words "a position may not be disestablished where" in Clause 28 be deleted, and the words "an exception has been made under section 91 of the Education Act 1989" be substituted therefor.
- 4.**           **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.

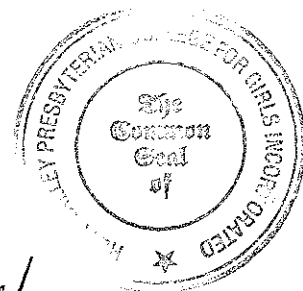
