SUPPLEMENTARY DEED OF AGREEMENT

SAINT PATRICK'S SCHOOL, BRYNDWR

THIS DEED OF AGREEMENT is made on the 11th day of *December*

One thousand nine hundred and eighty four (1984)

BETWEEN THE ROMAN CATHOLIC BISHOP OF THE DIOCESE

OF CHRISTCHURCH

a "Corporation Sole" (hereinafter with his

successors referred to as "the proprietor") of the first part

AND

HER MAJESTY THE QUEEN acting by and through the Minister of

Education (hereinafter referred to as "the Minister") of the

second part

WHEREAS

A. The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 14th day of November 1981

for Saint Patrick's School, BRYNDWR

(hereinafter referred to as the "original Deed of Agreement")

B. The Proprietor and the Minister pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975 signed a supplementary Deed of Agreement on the 30th day of January 1984

(hereinafter referred to as the "first supplementary Deed of Agreement").

C. The Proprietor and the Minister are now agreed on the need to further amend Clause 8 of the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED

AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS

FOLLOWS:-

1 THAT the words " one hundred and twenty five (125) pupils"

in the 5th line in Clause 8 of the original Deed of Agreement be deleted from that Agreement and the words "one hundred and fifty five (155) pupils" be substituted therefor.

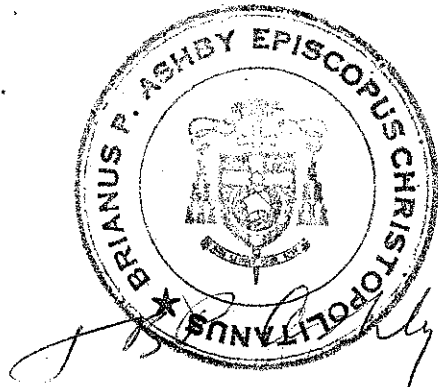
