

SUPPLEMENTARY DEED OF AGREEMENT

ST PATRICK'S COLLEGE, KILBIRNIE, WELLINGTON

THIS DEED OF AGREEMENT is made on the 9th day of December two thousand and fifteen (2015) BETWEEN **ST PATRICK'S COLLEGE WELLINGTON BOARD OF PROPRIETORS** a body Corporate registered under the Religious Charitable and Education Trusts Act 1957 (hereinafter with its successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS

- A By Deed of Agreement bearing date the 16th day of July 1981 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **St Patrick's College, Kilbirnie, Wellington** as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. **THAT** the words "eight hundred (800) pupils in the 5th line in clause 8 of the Deed of Agreement be amended from that Agreement and the words "approve a temporary maximum roll increase of eight hundred and thirty (830) students for 2016, 2017, 2018, eight hundred and twenty (820) for 2019, eight hundred and fifteen (815) for 2020 and eight hundred and ten (810) for 2021" be substituted therefor.
2. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
