

SUPPLEMENTARY DEED OF AGREEMENT

ST PATRICK'S SCHOOL PANMURE

THIS DEED OF AGREEMENT is made on the 4th day of ~~DECEMBER~~
One thousand nine hundred and eighty five (1985)
BETWEEN THE ROMAN CATHOLIC BISHOP OF THE DIOCESE
OF AUCKLAND a "Corporation Sole" (hereinafter with
his successors referred to as "the Proprietor") of
the first part and **HER MAJESTY THE QUEEN** acting by
and through the Minister of Education (hereinafter
referred to as "the Minister") of the second part
WHEREAS

A By Deed of Agreement bearing date the 14th
day of September 1982 as varied by any
subsequent supplementary agreements (hereinafter
referred to as "the Deed of Agreement"), the
Minister and the Proprietor pursuant to
section 7(2) of the Private Schools
Conditional Integration Act 1975 established
ST PATRICK'S SCHOOL PANMURE as an integrated
school.

B The Proprietor and the Minister are now agreed
on the need to amend Clause 8 of the Deed of
Agreement pursuant to Section 7(9) of the
Private Schools Conditional Integration Act
1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY
COVENANTED AGREED AND DECLARED BY AND BETWEEN THE
PARTIES HERETO AS FOLLOWS:

1 **THAT** the words "one hundred and thirteen
(113)" in the 4th line in Clause 8 of the
Deed of Agreement be deleted from that
Agreement and the words "one hundred and
twenty (120)" be substituted therefor.




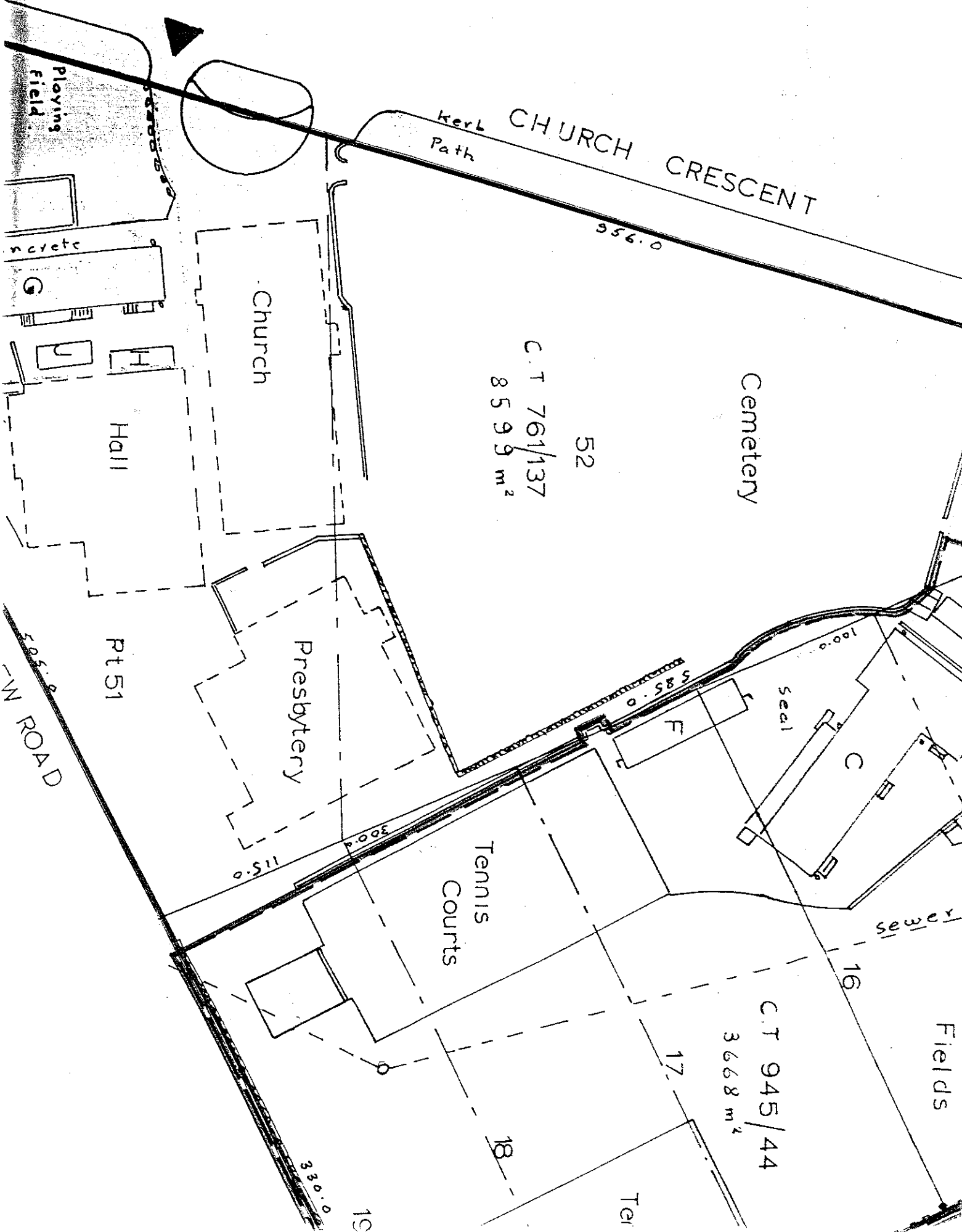
