

SUPPLEMENTARY DEED OF AGREEMENT**ST PATRICK'S SCHOOL, PANMURE**

THIS DEED OF AGREEMENT is made on the 9th day of April one thousand nine hundred and ninety-eight (1998) BETWEEN **THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF AUCKLAND** "a Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS

- A By Deed of Agreement bearing date the 14th day of September 1982 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **St Patrick's School, Panmure, Auckland** as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. **THAT** the Second Schedule of the Deed of Agreement and the Plan attached thereto be deleted and replaced by the new Second Schedule and Plan attached hereto.
2. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.



SECOND SCHEDULE

Description of land, buildings and other improvements comprising the school premises

The School Premises:

All that part of the Proprietor's land as described in the **First Schedule** hereto, delineated in red on the annexed plan of the Proprietor's land, which forms part of this Schedule, **TOGETHER WITH** all the School buildings and other improvements thereon, **SAVE AND EXCEPT** Blocks D, E and G more particularly delineated in blue on the said plan **TOGETHER WITH** a reservation in favour of that excepted portion of ingress and egress between that excepted portion and Church Crescent, Panmure.
