SUPPLEMENTARY DEED OF AGREEMENT

THIS DEED OF AGREEMENT is made on the 16th day of August
One Thousand nine hundred and eighty eight BETWEEN THE
ROMAN CATHOLIC BISHOP OF THE DIOCESE OF AUCKLAND a
'Corporation Sole' (hereinafter with his successors
referred to as "the Proprietor") of the first part and HER
MAJESTY THE QUEEN acting by and through the Minister of
Education (hereinafter referred to as "The Minister") of
the second part

WHEREAS

- A By Deed of Agreement bearing date the 14th day of
September 1982 as varied by any subsequent
supplementary agreements (hereinafter referred to as
"the Deed of Agreement"), the Minister and the
Proprietor pursuant to section 7(2) of the Private
Schools Conditional Integration Act 1975 established
Saint Patrick's School, PANMURE as an integrated
school.
- B The Proprietor and the Minister are now agreed on the
need to amend Clause 8 of the Deed of Agreement
pursuant to section 7(9) of the Private Schools
Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY
COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES
HERETO AS FOLLOWS:

1. THAT the words "one hundred and twenty pupils (120)" in the 4th line in clause 8 of the Deed of Agreement be deleted from that Agreement and the words "one hundred and forty pupils (140) " be substituted therefor.

2. THAT the Third Schedule of the original Deed of Agreement be amended by adding under the heading "Building Requirements" the words "additional: teaching space 65m², resource workroom 14m², staffroom 4.5m², staff kitchen 4.5m², principal's office 11m² , school office 8m²". This accommodation is to be provided by 1991. This work specified above is in addition to the work listed in the third schedule.

3. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
