

SUPPLEMENTARY DEED OF AGREEMENT

ST PATRICK'S COLLEGE, SILVERSTREAM

THIS DEED OF AGREEMENT is made on the *4th* day of *February*
One thousand nine hundred and eighty five (1985)


BETWEEN THE SILVERSTREAM COLLEGE TRUST BOARD a body corporate registered under the Charitable Trusts Act 1957 (hereinafter with its successors referred to as "the proprietor") of the first part
AND HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

WHEREAS

- A. The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 31st day of March 1983 for St Patrick's College, SILVERSTREAM (hereinafter referred to as the original Deed of Agreement")
- B. The Proprietor and the Minister pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975 signed a second supplementary Deed of Agreement on the 17th day of April 1984 (hereinafter referred to as the "second supplementary Deed of Agreement")
- C. The Proprietor and the Minister are now agreed on the need to further amend Clause 8 of the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1 THAT the words "six hundred and ninety-six (696) pupils" in the 4th line in Clause 8 of the original Deed of Agreement as amended by the second supplementary Deed of Agreement be deleted from that Agreement and



the words "seven hundred and fifty (750) pupils" be substituted therefor and the words "three hundred and ten (310)" in line 5 of the original Deed of Agreement be deleted and the words "three hundred and eighty (380)" be substituted therefor.

2 THAT the Third Schedule to the original Deed of Agreement be amended on page 3 of the Third Schedule by deleting under the heading "Provide by new construction or remodelling" the words "7 standard classrooms of 58m²" and substituting therefor the words "8 standard classrooms of 58m²." These items are to be completed by 31 March 1988.

3 THAT the covenants conditions and restrictions contained and implied in the said Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the said Deed of Agreement is confirmed.
