

SUPPLEMENTARY DEED OF AGREEMENT

St Patrick's School, Te Awamutu

THIS DEED OF AGREEMENT is made on the *fourteenth* day of *December* One Thousand nine hundred and eighty *nine* BETWEEN THE
THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF HAMILTON a
'Corporation Sole' (hereinafter with his successors
referred to as "the Proprietor") of the first part and HER
MAJESTY THE QUEEN acting by and through the Minister of
Education (hereinafter referred to as "The Minister") of
the second part

WHEREAS

- A By Deed of Agreement bearing date the 28th day of
April 1981 as varied by any subsequent supplementary
agreements (hereinafter referred to as "the Deed of
Agreement"), the Minister and the Proprietor pursuant
to section 7(2) of the Private Schools Conditional
Integration Act 1975 established St Patrick's School,
Te Awamutu as an integrated school.
- B The Proprietor and the Minister are now agreed on the
need to amend Clause 8 of the Deed of Agreement
pursuant to section 7(9) of the Private Schools
Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY
COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES
HERETO AS FOLLOWS:

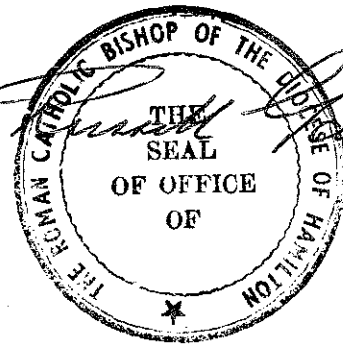
1. THAT the words "two hundred and sixty-five" in the
5th line in clause 8 of the Deed of Agreement be
deleted from that Agreement and the words "two
hundred and ninety-one " be substituted therefor.

2. THAT the Third Schedule of the original Deed of Agreement be amended by adding under the heading "Building Requirements" the words "classroom of 65m²". This accommodation is to be provided by 1990. This work specified above is in addition to the work listed in the third schedule.

3. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
