PARTIES

THE NEW ZEALAND MARIST BROTHERS TRUST BOARD ("Original Proprietor")

ST PAUL'S AUCKLAND COLLEGE LIMITED ("New Proprietor")

HER MAJESTY THE QUEEN ACTING BY AND THROUGH THE MINISTER OF EDUCATION ("Minister of Education")

INTRODUCTION

- A. The Original Proprietor and the Minister of Education pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 by deed of agreement dated 8 August 1982 as varied by supplementary agreements ("**Integration Agreement**") established St Paul's College Auckland ("**School**") as an integrated school.
- B. The Original Proprietor established a company under the Companies Act 1993 known as "St Paul's College Auckland Limited" to be the New Proprietor of the School subject to the Integration Agreement and the written approval of the Minister of Education.
- C. The Minister of Education is satisfied that the New Proprietor is a suitable candidate to fulfil the role of Proprietor of the School, and is capable of discharging such proprietor responsibilities under the Integration Agreement and Private Schools Conditional Integration Act 1975 ("**Integration Act**"), including responsibility for supervising, maintaining and preserving the education with a special character provided by the School, as defined in the Integration Agreement. On that basis, the Minister of Education agreed to the Original Proprietor transferring the School subject to the Integration Agreement to the New Proprietor on the condition that the parties record their intention to transfer in writing.
- D. The Original Proprietor and the Minister of Education signed a supplementary agreement dated 11 November 2004 to record the parties' mutual intention to transfer of the Integration Agreement for the School to the New Proprietor. The New Proprietor was not a party to that supplementary agreement.
- E. The Original Proprietor, the New Proprietor and the Minister of Education, following legal advice, agree that it is necessary for each party to sign this deed in support of the supplementary agreement evidencing the intention of the Minister of Education and the Original Proprietor to transfer of the proprietorship of the School to the New Proprietor, in order to record their agreement and give legal effect to the transfer of proprietorship.

OPERATIVE PROVISIONS

1. TRANSFER OF PROPRIETOR OF SCHOOL

- 1.1 The Original Proprietor hereby transfers all its right title and interest as proprietor of the School under the Integration Agreement to the New Proprietor as from the Effective Date.
- 1.2 The New Proprietor hereby accepts the transfer of the interest of the Original Proprietor as proprietor of the School under the Integration Agreement as from the Effective Date and agrees to be bound by all the terms of the Integration Agreement and accepts all applicable obligations, duties and responsibilities of proprietor of the School as prescribed under the Integration Act.
- 1.3 The Minister of Education hereby releases the Original Proprietor from all obligations, duties and responsibilities held by it under the Integration Agreement and under the Integration Act, and consents to the transfer of the interest of the Original Proprietor of the School under the Integration Agreement to the New Proprietor as from the Effective Date.

2. EFFECTIVE DATE


- 2.1 The effective date of this supplementary agreement is the date it is signed by all parties as evidenced by the date of this deed ("**Effective Date**").


3. CONFIRMATION OF INTEGRATION AGREEMENT

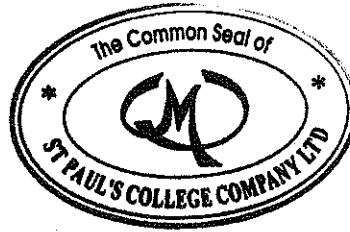
