### SUPPLEMENTARY DEED OF AGREEMENT

## ST PAUL'S SCHOOL, RICHMOND

THIS DEED OF AGREEMENT is made on the day of two thousand and two (2002) **BETWEEN THE ROMAN CATHOLIC ARCHBISHOP OF THE ARCHDIOCESE OF WELLINGTON** a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

#### WHEREAS

- A By Deed of Agreement bearing date the twenty-sixth (26<sup>th</sup>) day of January, one thousand, nine hundred and ninety-nine (1999) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **St Paul's School, Richmond** as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister wish to vary the Deed of Agreement to amend Clause 8 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

# NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- THAT the words "one hundred and eighty two (182)" in the second line in Clause 13 of the Deed of Agreement be deleted from that Agreement and the words "two hundred and thirty five (235)" be substituted therefor.
- **THAT** in Clause 16 of the Deed of Agreement the words "be limited at all times to eight (8) per cent of the maximum roll as determined by Clause 13 hereof" be deleted from that Agreement and the words "be limited to 10 pupils" be substituted therefor.
- 3. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
