

**SUPPLEMENTARY DEED OF AGREEMENT**

SAINT PETER CHANEL SCHOOL, OTAKI

**THIS DEED OF AGREEMENT** is made on the 3<sup>rd</sup> day of *September*  
One thousand nine hundred and eighty-five (1985) **BETWEEN**  
**THE ROMAN CATHOLIC ARCHBISHOP OF THE ARCHDIOCESE OF**  
**WELLINGTON** a "Corporation Sole" (hereinafter with his  
successors referred to as "the Proprietor") of the first  
part **AND HER MAJESTY THE QUEEN** acting by and through the  
Minister of Education (hereinafter referred to as "the  
Minister") of the second part

**WHEREAS**

- A** By Deed of Agreement bearing date of 27th day of  
August 1981, (hereinafter referred to as "the Deed  
of Agreement") the Minister and the Proprietor  
pursuant to Section 7 (2) of the Private Schools  
Conditional Integration Act 1975 established  
Saint Peter Chanel School, Otaki (hereinafter  
referred to as "the School") as an integrated  
school.
- B** The Proprietor and the Minister are now agreed on  
the need to redefine the School Premises as  
described in the Second Schedule to the Deed of  
Agreement by entering into a supplementary agreement  
pursuant to Section 7 (9) of the Private Schools  
Conditional Integration Act 1975

**NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY**  
**CONVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES**  
**HERETO AS FOLLOWS:**

- 1** **THAT** the Deed of Agreement bearing date the 27th  
day of August 1981, is hereby amended by deleting  
and cancelling the Second Schedule and annexed  
plan.
- 2** **THAT** the Schedule and plan attached to this  
Supplementary Deed of Agreement are hereby  
substituted as the Second Schedule defining the  
School Premises in the Deed of Agreement.

Description of land, buildings and other improvements comprising the School premises.

THE SCHOOL PREMISES

All that part of the Proprietor's land as described in the First Schedule hereto, delineated in red on the annexed plan of the Proprietor's land, which plan forms part of this Schedule TOGETHER WITH all the School buildings and other improvements thereon. SAVE AND EXCEPT the Convent (Block E) the Church (Block G) the Presbytery (Block H) and buildings shown as Blocks B, C, F, I, J, K and L and the land immediately surrounding the same being more particularly delineated in green on the annexed plan TOGETHER WITH a reservation in favour of those excepted portions of full rights of access inter se and of ingress and egress to and from those excepted portions over the access thereto shaded blue on the annexed plan from and to Convent Road, Otaki.
