SUPPLEMENTARY DEED OF AGREEMENT

SAINT PETER CHANEL SCHOOL, TE RAPA

THIS DEED OF AGREEMENT is made on the / day of November.

One thousand nine hundred and eighty-three (1983) BETWEEN

THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF HAMILTON

a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part AND HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

WHEREAS

- The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 14th day of September 1982 for St Peter Chanel School, TE RAPA (hereinafter referred to as the "original Deed of Agreement").
- The Proprietor and the Minister pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975 signed a supplementary Deed of Agreement on the 4th day of December 1982 (hereinafter referred to as the "first supplementary Deed of Agreement").
- The Proprietor and the Minister are now agreed on the need to further amend Clause 8 of the original Deed of Agreement pursuant to section 7 (9) of the Private Schools Conditional Integration Act 1975 as amended by the first supplementary Deed of Agreement.

NOW THIS DEED OF AGREEMENT WITNESSTH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:-

1 THAT the words "one hundred and fifty-five (155) pupils" in the 4th line in Clause 8 of the original Deed of Agreement as amended by the first supplementary Deed of Agreement be deleted from that Agreement and the words "one hundred and sixty-five (165) pupils" be substituted therefor.

- THAT the Third Schedule to the original Deed of Agreement be 4 amended on page 19 of that agreement under the heading "BUILDING REQUIREMENTS" by adding as a new item the words "Provide storage of 21 m²". This item is to be completed by March 1985.
- THAT the covenants conditions and restrictions contained and implied in the said Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the said Deed of Agreement is confirmed.
