

SUPPLEMENTARY DEED OF AGREEMENT

SAINT PETER'S CATHOLIC SCHOOL, CAMBRIDGE

THIS DEED OF AGREEMENT is made on the / day of *NOVEMBER*,

One thousand nine hundred and eighty-three (1983) BETWEEN

THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF HAMILTON

a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part AND HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

WHEREAS

- A The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 7th day of APRIL 1981 for St Peter's Catholic School, CAMBRIDGE (hereinafter referred to as the "original Deed of Agreement").
- B The Proprietor and the Minister pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975 signed a supplementary Deed of Agreement on the 1st day of October 1982 (hereinafter referred to as the "first supplementary Deed of Agreement").
- C The Proprietor and the Minister are now agreed on the need to further amend Clause 8 of the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975 as amended by the first supplementary Deed of Agreement.

NOW THIS DEED OF AGREEMENT WITNESSTH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:-

- 1 THAT the words "one hundred and seventy-five (175) pupils" in the 5th line in Clause 8 of the original Deed of Agreement as amended by the first supplementary Deed of Agreement be deleted from that Agreement and the words "two hundred (200) pupils" be substituted therefor.

2 THAT the Third Schedule to the original Deed of Agreement be amended on page number 22 of that Agreement by inserting under the words "BUILDING REQUIREMENTS" the words "Additional teaching space of 65m²". This item is to be completed by 31 March 1987.


