

SUPPLEMENTARY DEED OF AGREEMENT

SAINT PETER'S CATHOLIC SCHOOL, CAMBRIDGE

THIS DEED OF AGREEMENT is made on the 5th day of February

One thousand nine hundred and eighty-five (1985) BETWEEN

THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF HAMILTON

a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part AND HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

WHEREAS

- A The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 7th day of APRIL 1981 for St Peter's Catholic School, CAMBRIDGE (hereinafter referred to as the "original Deed of Agreement").
- B The Proprietor and the Minister pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975 signed a second supplementary Deed of Agreement on the 1st day of November 1983 (hereinafter referred to as the "second supplementary Deed of Agreement").
- C The Proprietor and the Minister are now agreed on the need to further amend Clause 8 of the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975 as amended by the second supplementary Deed of Agreement.

NOW THIS DEED OF AGREEMENT WITNESSTH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:-

1 THAT the words "one hundred and seventy-five (175) pupils" in the 5th line in Clause 8 of the original Deed of Agreement as amended by the second supplementary Deed of Agreement be deleted from that Agreement and the words "two hundred and ten (210) pupils" be substituted therefor.

2 THAT the covenants conditions and restrictions contained and implied in the original deed of agreement shall be read and construed subject to the modifications herein contained but in all othe respects the original deed of agreement is confirmed.
