

SUPPLEMENTARY DEED OF AGREEMENT

ST PETER'S COLLEGE, PALMERSTON NORTH

THIS DEED OF AGREEMENT is made on the *28th* day of *April* One thousand nine hundred and ninety-eight (1998) between **THE ROMAN CATHOLIC BISHOP OF PALMERSTON NORTH** a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS

- A** By Deed of Agreement bearing date the 15th day of March, One thousand nine hundred and eighty two (1982) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **St Peter's College, Palmerston North** as an integrated school (hereinafter referred to as "the school").
- B** The Proprietor and the Minister are now agreed on the need to change the class of the school to a **Years 7 to 13 school** consequent upon the closure of the **attached Intermediate Department of the School** pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

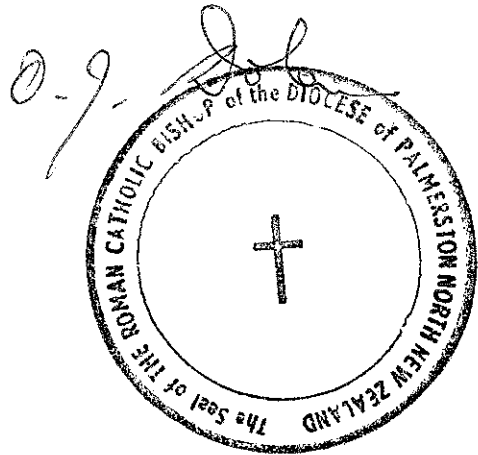
- 1** THAT the Integration Agreement be amended as follows :
- 2** By deleting from **Recital B** the words "Form Three (III) to Form Seven (VII) with an Intermediate Department attached" and substituting the words "Years 7 to 13" therefor.
- 3** By deleting **Clause 8** and substituting the following Clause therefor: "The combined maximum rolls of St Peter's College and the attached Intermediate Department totalled eight hundred and ninety (890) pupils as at the 15th day of May 1997. It is agreed by and between the parties hereto that the maximum roll of the school shall be eight hundred and ninety (890) pupils."
- 4** By deleting from **Clause 23** the words "from Form Three (III) to Form (VII) with an Intermediate Department attached" and substituting the words "from Years 7 to 13" therefor.

- 5 By deleting **Clause 17** of the Deed of Agreement.
- 6 In Clause 18 of the Deed of Agreement
 - 07X (a) By deleting from line^s 14 the words "the Form III to Form VII section of" ^{and}
 - (b) In lines 3 and 14 by replacing "twenty-five decimal eight five (25.85)" with "thirty-three decimal eight five (33.85)"
 - (c) In lines 5 and 20 by replacing "ten (10)" with "fourteen (14)".
- 7 By deleting the **Fourth Schedule** to the Deed of Agreement.
- 8 **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
