

SUPPLEMENTARY DEED OF AGREEMENT

ST PIUS X SCHOOL, TITAHI BAY

THIS DEED OF AGREEMENT is made on the <sup>3<sup>rd</sup></sup> day of <sup>March</sup> One thousand nine hundred and ninety <sup>Five</sup> (1995) BETWEEN THE ROMAN CATHOLIC ARCHBISHOP OF THE ARCHDIOCESE OF WELLINGTON a Corporation sole (hereinafter with his successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS

- A By Deed of Agreement bearing date the 1 day of October One Thousand nine hundred and eighty-one (1981) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established St Pius X School, TITAHI BAY as an integrated school (hereinafter referred to as "the School")
- B The Proprietor and the Minister wish to vary the Deed of Agreement to allow the establishment of an Early Childhood Centre within the School Premises.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. THAT the following Clause is an addition to the Deed of Agreement:

- (a) "Nga Manawa iti Kohanga will occupy the area described as area 14 in drawing No. EIP 122 02 attached hereto for the period from 30 January 1995 to 31 December 1995 and will have full right of access to and from the aforesaid area over the School Premises and to and from the toilets.
  
- (b) Notwithstanding Clause 29 hereof the maintenance for the aforesaid area 14 will not be the responsibility of the Minister during the period, and as a consequence the operations grant for the Board of Trustees will be adjusted."

2. THIS supplementary agreement will be deemed to be cancelled on the expiry of the period specified in Clause 1(a) of this Deed and this Deed ceases to apply from that date.

3. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.


