SUPPLEMENTARY DEED OF AGREEMENT

SAINT TERESA'S SCHOOL, FEATHERSTON

THIS DEED OF AGREEMENT is made on the 30th day of January  
One thousand nine hundred and eighty five (1985)

BETWEEN THE ROMAN CATHOLIC BISHOP OF THE ARCHDIOCESE  
OF WELLINGTON a "Corporation Sole" (hereinafter with his  
successors referred to as "the proprietor") of the first part  
AND HER MAJESTY THE QUEEN acting by and through the Minister of  
Education (hereinafter referred to as "the Minister") of the  
second part

WHEREAS

- A. The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 20th day of December 1981 for St Teresa's School, Featherston (hereinafter referred to as the "original Deed of Agreement")
- B. The Proprietor and the Minister pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975 signed a supplementary Deed of Agreement on the 8th day of March 1983 (hereinafter referred to as the "first supplementary Deed of Agreement").
- C. The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED  
AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS  
FOLLOWS:-

1 THAT the words "one hundred and ten pupils"  
in the 5th line in Clause 8 of the original Deed of Agreement be deleted  
from that Agreement and the words "one hundred and twenty five (125)"  
be substituted therefor.

2 THAT the Third Schedule to the original Deed of Agreement be amended on page number 7 of that agreement by deleting under the heading "Provide the following facilities to code requirements by remodelling in Block A" the words "Class teaching space of 100m<sup>2</sup> " and substituting therefor the words "Class teaching space of 165m<sup>2</sup> " this item to be completed by 31 March 1985 and also by adding the following words "resource workroom 14m<sup>2</sup> principal's office 11m<sup>2</sup> school office 8m<sup>2</sup> " these items to be completed by 31 March 1988.

3 THAT the covenants conditions and restrictions contained and implied in the original Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the original Deed of Agreement is confirmed.
