## SUPPLEMENTARY DEED OF AGREEMENT

ST TERESA'S SCHOOL, KARORI

THIS DEED OF AGREEMENT is made on the 5th day of December One thousand nine hundred and eighty four (1984) BETWEEN

THE ROMAN CATHOLIC ARCHBISHOP OF THE ARCHDIOCESE OF WELLINGTON

a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part AND HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

## WHEREAS

- A The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 20th day of May 1982 for St Teresa's School, KARORI (hereinafter referred to as the "original Deed of Agreement")
- B The Proprietor and the Minister are now agreed on the need to amend Clause 8 on the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

## NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1 THAT the words "two hundred and seventy (270)"
in the 5th line in Clause 8 of the original Deed of Agreement be deleted from that Agreement and the words "three hundred and five (305)" be substituted therefor.

 $\frac{2}{2}$  THAT the Third Schedule to the original Deed of Agreement be amended on page 29 of that agreement by inserting under the words "Building Requirements" the words "Provide by new construction or remodelling the following: teaching space totalling  $580\text{m}^2$  resource/workroom area totalling  $28\text{m}^2$  storage totalling  $42\text{m}^2$ 

These items are to be completed by 31/3/86"

3 THAT the covenants conditions and restrictions contained and implied in the original Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the original Deed of Agreement is confirmed.
