

SUPPLEMENTARY DEED OF AGREEMENT

ST TERESA'S SCHOOL, KARORI, WELLINGTON

THIS DEED OF AGREEMENT is made on the 9th day of March two thousand and eleven (2011) **BETWEEN THE ROMAN CATHOLIC ARCHBISHOP OF THE ARCHDIOCESE OF WELLINGTON**, a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS


- A** By Deed of Agreement bearing date the twentieth (20th) day of May, one thousand, nine hundred and eighty two (1982) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **St Teresa's School, Karori** as an integrated school (hereinafter referred to as "the School").
- B** The Proprietor and the Minister wish to vary the deed of Agreement to amend Clause 10(b) of the Deed Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:


1. **THAT** in Clause 10(b) of the Deed of Agreement the words "thirteen (13) pupils" be deleted from that Agreement and the words "five per cent of the total maximum roll" be substituted therefor.
2. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
