

**SUPPLEMENTARY DEED OF AGREEMENT**

**ST TERESA'S SCHOOL PLIMMERTON**

**THIS DEED OF AGREEMENT** is made on the 3rd day of DECEMBER  
One thousand nine hundred and eighty five (1985)

**BETWEEN THE ROMAN CATHOLIC ARCHBISHOP OF THE ARCHDIOCESE**

**OF WELLINGTON** a "Corporation Sole" (hereinafter with  
his successors referred to as "the Proprietor") of  
the first part and **HER MAJESTY THE QUEEN** acting by  
and through the Minister of Education (hereinafter  
referred to as "the Minister") of the second part

**WHEREAS**

**A** By Deed of Agreement bearing date the 21st day  
of July 1981 as varied by any subsequent  
supplementary agreements (hereinafter referred  
to as "the Deed of Agreement"), the Minister  
and the Proprietor pursuant to section 7(2) of  
the Private Schools Conditional Integration  
Act 1975 established **St Teresa's School  
Plimmerton** as an integrated school.

**B** The Proprietor and the Minister are now agreed  
on the need to amend Clause 8 of the Deed of  
Agreement pursuant to Section 7(9) of the  
Private Schools Conditional Integration  
Act 1975.

**NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY  
COVENANTED AGREED AND DECLARED BY AND BETWEEN THE  
PARTIES HERETO AS FOLLOWS:**

- 1** **THAT** the words "one hundred and ninety (190)  
in the 5th line in Clause 8 of the Deed of  
Agreement be deleted from that Agreement and  
the words "Two hundred and ten (210)" be  
substituted therefor.
- 2** **THAT** the Third Schedule to the Deed of Agreement  
be amended by adding under the heading "BUILDING  
REQUIREMENTS" the following "Additional teaching  
space of 65m<sup>2</sup>. This item to be completed by  
31 March 1988."






