SUPPLEMENTARY DEED OF AGREEMENT

ST. THERESE'S SCHOOL, THREE KINGS

THIS DEED OF AGREEMENT is made on the day of From One thousand nine hundred and ninety-three (1993) BETWEEN

THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF AUCKLAND a

"Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and HER

MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS

- By Deed of Agreement bearing date the 27th day of January 1983 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established St. Therese's School, Three Kings, as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975 to enable boys to continue to attend the school up to Form 2.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1. THAT the Deed of Agreement bearing date the 27th day of January 1983 is hereby amended by deleting Recital B and substituting therefore
- "B The School is a Roman Catholic Primary School for boys and girls from new entrants to Form Two (2) offering Education with a Special Character".

(F) A p.3.

- THAT Clause 23 on page 11 of the Deed of Agreement be amended by deleting the words "girls from new entrants to Form Two (2) and boys from new entrants to Standard Four (4) and" and substituting the words "boys and girls from new entrants to Form Two (2)".
- THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
