

SUPPLEMENTARY DEED OF AGREEMENT

Star of the Sea School, HOWICK

THIS DEED OF AGREEMENT is made on the *6th* day of *May*  
One Thousand nine hundred and ninety (1990) BETWEEN THE  
ROMAN CATHOLIC BISHOP OF THE DIOCESE OF AUCKLAND a  
Corporation Sole (hereinafter with his successors referred  
to as "the Proprietor") of the first part and HER MAJESTY  
THE QUEEN acting by and through the Minister of Education  
(hereinafter referred to as "The Minister") of the second  
part

WHEREAS

- A By Deed of Agreement bearing date the 12th day of  
October 1982 as varied by any subsequent  
supplementary agreements (hereinafter referred to as  
"the Deed of Agreement"), the Minister and the  
Proprietor pursuant to section 7(2) of the Private  
Schools Conditional Integration Act 1975 established  
Star of the Sea School, HOWICK as an integrated  
school.
- B The Proprietor and the Minister are now agreed on the  
need to amend Clause 8 of the Deed of Agreement  
pursuant to section 7(9) of the Private Schools  
Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY  
COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES  
HERETO AS FOLLOWS:

1. THAT the words "one hundred and ninety-one (191)" in  
the 4th line in clause 8 of the Deed of Agreement be  
deleted from that Agreement and the words "two  
hundred and forty-seven (247) " be substituted  
therefor.

2. THAT the Third Schedule of the original Deed of Agreement be amended by adding to sheet 9 after the words "1 WHB for boys toilets" the words "teaching space of 125m<sup>2</sup> and staffroom space of 9 m<sup>2</sup>". This accommodation is to be provided by 1993.

3. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
